MWRD commissioners salute new House Speaker Welch

The Metropolitan Water Reclamation District of Greater Chicago (MWRD) Board of Commissioners passed a resolution honoring the state's first black Speaker of the Illinois House of Representatives Emanuel "Chris" Welch.

Speaker Welch has been an instrumental partner to the MWRD, striving to protect the region's water environment and address flooding issues, most recently partnering with the MWRD and local municipalities in the west suburbs to deliver the MWRD's Addison Creek Reservoir and Channel improvements projects.

These critical flood control projects will provide significant benefits to communities along Addison Creek, including Bellwood, Northlake, Stone Park, Melrose Park, Westchester and Broadview. The 600-acre-foot Addison Creek Reservoir, located in Speaker Welch's district in Bellwood, will hold close to 200 million gallons of storage capacity and connect with the Addison Creek Channel. The MWRD project is on track for completion by late 2022.

"We are proud to recognize Speaker Welch as a partner and strong advocate for our water environment," said MWRD Board President Kari K. Steele. "We applaud Speaker Welch and the Illinois House of Representatives on his historic election as house speaker, and we look forward to many years of collaboration. His dedication and accomplishments as a new leader for

Speaker Welch began serving in the Illinois House in 2013, before being elected by his colleagues as House Speaker on Jan. 13, 2021. He was born in Chicago, attended Proviso West High School in Hillside, earned a bachelor's degree from Northwestern University's School of Communication and earned a law degree from John Marshall Law School (now UIC John Marshall Law School).

EMANUEL "CHRIS" WELCH

WHEREAS, for the first time in the 203-year history of the Stare of Illinois, an African American has been elected as the presiding officer of its legislative branch's lower house. On January 13, 2021, Representative Emanuel 'Chris' Welch was elected the 70th speaker of the House of Representatives for the 102and Illinois General Assembly. Representative Emanuel 'Chris' Welch's name will be etched into history alongside of others such as John W.E. Thomas, the first African American elected to the legislature in 1877; and

WHEREAS, on March 20, 2012, Representative Welch won the Democratic primary to serve the 7th District in the Illinois House of Representatives. He ran unopposed in the general election and was officially elected on November 6, 2012. Representative Welch began serving his first term in the Illinois House of Representatives in January of 2013. Since that time, Representative Welch has successfully defended his seat; and

WHEREAS, while serving in the Illinois
House of Representatives, Representative Welch has
served on the following committees Appropriations-Hementary
and Secondary Education, Appropriations-Higher Education,
Cities and Villages, Countries and Townships, Elementary and
Secondary Education School Curriculum Policies, Executive
(Chairman), Health Care Availability Access, Higher Education
(as Committeeman, Vice-Chairman, and Chairman), Insurance,
Judiciary-Civil, Judiciary-Civininal, Labor and Commerce,
Revenue and Finance, Small Business Empowerment and
Workforce Developments, Usubarance Abuse, and TransportationRegulation, Roads, and Bridges; and

WHEREAS, among his many honors, Representative Welch has received the Zeke Giorgi Award from the AFL-CIO, the Friend and Education Award from the Illinois Education Association, and was a 2016 inductee into the John Marshall Law School Wall of Fame; and

WHEREAS, Representative Emanuel "Chris" Welch was born in Chicago, Illinois. In 1989, Representative Welch graduated from Proviso West High School in Hillside, Illinois. Following graduation, he attended Northwestern University where he earned his Bachelor's degree from the School of Communication. In 1997, Representative Welch graduated from John Marshall Law School (now UIC John Marshall Law School) with his Juris Doctorate; and

WHEREAS, Representative Emanuel "Chris" Welch is a leader and a role model. He has demonstrated through his numerous accomplishments that hard work and dedication are the principles of success. He is a reminder that perceived barriers are not impediments but in fact challenges that inspire greater achievements; and

WHEREAS, Representative Emanuel "Chris" Welch is a proud member of Alpha Phi Alpha Fraternity, Inc.; and

NOW, THEREFORE, BE IT RE-

SOLVED, that we, the Board of Commissioners of the Metropolitan Water Reclamation District of Greater Chicago, on behalf of ourselves and staff, do hereby acknowledge the achievement of Representative Emanuel "Chris" Welch being elected as the first Black Speaker of the Illinois House of Representatives, and

BE IT FURTHER RESOLVED, that this Resolution be spread upon the permanent Record of Proceedings of the Board of Commissioners of the Metropolitan Water Reclamation District of Greater Chicago and that a copy of same, suitably engrossed, be presented to Speaker of the Illinois House of Representatives Emanuel "Chris" Welch.
